All teams should be prepared to play every Monday and Thursday through the conclusion of tournament.



Covid-19 Policies

- * Team bench is restricted to rostered team members who are participating in the game.
- * Masks should be worn at all times by players, spectators and staff, even when participating in games, in accordance with NC Governor's order. When playing in the field, participants do not have to wear masks. Masks should be worn in the dugouts and any time 6' distance between others cannot be achieved. Covid protocol is subject to change with direction of the local, state and federal government and health department as well as NCHSAA restrictions and guidelines.
- * Hand sanitizer and equipment wipes will be supplied and should be used regularly.
- * Participants should self monitor prior to attending games. Participants with a fever, cough, shortness of breath, diarrhea, or other Covid-19 symptom should not attend games. Anyone potentially exposed to Covid-19 or confirmed with Covid-19 shall not attend games as a participant or spectator until mandated quarantine is met.
- * Teams should arrive no more than 10 minutes prior to game time.
